Product Description:

The AR-104 is a heavy-duty cleaner/restorer and can be used on a wide variety of stone surfaces safely and effectively. This product is mostly effective on limestone, marble and travertine, removing accumulated surface contaminants, mineral deposits and atmospheric stains. It can be used for both interior and exterior applications. This product does not contain any harsh solvents, phosphates, caustics or acid.

Application:

AR-104 should be generously brushed or sprayed onto a dry surface being cleaned from the bottom up. Saturate surface for optimum cleaning. Let solution stand for approximately 5-15 minutes, depending on surface and contaminants, moderately agitate and then rinse thoroughly. There is no need to mask off glass or metal surfaces and since the rinse water is pH neutral, there is no need for collection of the wastewater.

Test Area:

It is often impossible to know all of the surface conditions of the surface before cleaning. Before a project is started, it is important that a small test area be done typical of the surface to be cleaned.
